## NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Notice of Release”) is made as of April 12, 2023 (“Effective Date”), by FIRST HORIZON BANK (successor to First Tennessee Bank National Association), as administrative agent (“Secured Party”), in favor of SHARI’S MANAGEMENT CORPORATION, a Delaware corporation, CARROWS RESTAURANTS, LLC, a California limited liability company, and COCO’S RESTAURANTS, LLC, a California limited liability company (collectively, “Debtor”).

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement dated as of March 30, 2018 (the “Security Agreement”), Debtor assigned, transferred and conveyed to the Secured Party a security interest in all of Debtor’s right, title, and interests in and to the “Collateral” as defined therein;

WHEREAS, the security interests of Secured Party in the trademark registrations and trademark applications listed on Schedule A hereto (collectively, the “Released Trademark Collateral”) was recorded with the United States Patent and Trademark Office (“USPTO”) at Reel 006430, Frame 0128, pursuant to that certain Trademark Security Agreement, dated as of August 17, 2018, by Debtor in favor of Secured Party;

WHEREAS, Secured Party has agreed to release its liens on all of the Collateral, including, without limitation, the Released Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby covenants and agrees as follows:

1. Secured Party’s mortgage, pledge, hypothecation, and liens on, and security interest in, the Released Trademark Collateral is hereby terminated and released.
2. To the extent Secured Party retains any such interests, Secured Party hereby assigns, transfers and conveys to the applicable Debtor, all of Secured Party’s rights, title and interests, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interests and collateral assignment in the Released Trademark Collateral. Such assignment, transfer and conveyance by Secured Party is made without any representation or warranty (express or implied) by Secured Party.
3. Secured Party authorizes and requests the USPTO to record this Notice of Release.
4. Delivery of an executed signature page to this Notice of Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed signature page of this Notice of Release.
