PARTIAL RELEASE OF ABL TRADEMARK SECURITY AGREEMENT

April 1, 2023

WHEREAS, pursuant to that certain ABL Trademark Security Agreement by and among Royal Bank of Canada, in its capacity as Collateral Agent (in such capacity, "Releasor"), Salt Plains Storage, LLC ("Releasee") and Wild Goose Storage, LLC (the "Trademark Security Agreement"), Releasee and Wild Goose Storage, LLC created in favor of Releasor a security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the ABL Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 27, 2016 at Reel/Frame 5951/0933; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Partial Release of ABL Trademark Security Agreement to confirm the release, relinquishment and discharge of its security interest solely in the Trademark Collateral owned by Releasee and listed on Schedule 1 hereto (the "Released Trademarks").

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.


2. Release of Security Interest. Releasor hereby terminates, releases, relinquishes and discharges its security interest, and any other right, title and interest of Releasee, solely in the Released Trademarks, without recourse or representation or warranty, express or implied, of any kind. Nothing contained herein shall constitute or be construed as a termination, release, retransfer or reassignment by Releasor of its security interest, or any other right, title and interest, the Releasor may have in any Trademark Collateral (other than the Released Trademarks as set forth herein), which shall continue in full force and effect.

3. Authorization. Releasor hereby authorizes Releasee or Releasee's agent to record this Partial Release of ABL Trademark Security Agreement with the United States Patent and Trademark Office.
