**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 18, 2023 (“Release”), is made by Capitalspring Agency Services, LLC, a Delaware limited liability company, as Agent (“Agent”) in favor of Connor Concepts, Inc., a Tennessee corporation (“Secured Party”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of the Closing Date (as defined therein) (as amended from time to time, the “Security Agreement”) by and among the Secured Party and Agent, the Secured Party granted to the Agent, for the benefit of the Lenders, a continuing security interest in, and a continuing lien upon, the Collateral, including the trademarks listed on Schedule A attached hereto, and all applications, registrations, renewals and proceeds (including accounts receivable and royalties) thereof, together with the goodwill of the business connected with the use of and symbolized by the foregoing (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Secured Party executed and delivered to Agent the Memorandum of Security Agreement (Trademarks) recorded at the United States Patent and Trademark Office (“USPTO”) on November 25, 2019 at Reel 6803 Frame 0364 (“Memo”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Lenders, and Secured Party agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Memo.

SECTION 2. Termination and Release. Agent, on behalf of the Lenders, hereby:

- (a) terminates the Trademark Security Agreement and Memo;
- (b) terminates, cancels, discharges, and releases the continuing security interest in, and a continuing lien upon the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with the USPTO at Secured Party’s expense.

SECTION 3. Further Assurances. Agent, at Secured Party’s expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Agent will, at Secured Party’s expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
