## TRADEMARK ASSIGNMENT

Assignor further covenants that, when requested, it will, without charge to Assignor and at Assignee’s cost, execute all documents and take all such further actions as may be necessary, desirable or convenient to enable Assignee to obtain, maintain and enforce its rights and interest in and to the Trademarks in any and all countries.

This Assignment is binding on the Assignor and its successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.
