United States Patent and Trademark Office (“**USPTO**”)

Ladies and Gentlemen:

Reference is hereby made to the following documents (as each such document may be amended, restated, supplemented or otherwise modified from time to time, collectively, the “**Trademark Security Agreements**”):

- (i) the Security Agreement (Trademarks), dated as of November 15, 2011, by and between VINEBURG LLC, a California limited liability company (“**Vineburg**”), as borrower, and BMO HARRIS BANK, N.A., a national banking association and successor-in-interest to Bank of the West (“**BMO Harris**”), as lender, recorded with the USPTO on December 19, 2011 at Reel 004682 Frame 0451;
- (ii) the Security Agreement (Trademarks), dated as of March 31, 2017, by and between Vineburg, as borrower, and BMO Harris, as lender, recorded with the USPTO on May 8, 2017 at Reel 006051 Frame 0720; and
- (iii) the Security Agreement (Trademarks), dated as of November 13, 2020, by and between ECHO ECHO, LLC, a Delaware limited liability company (“**Echo Echo**”, and together with Vineburg, collectively the “**Grantors**” and each a “**Grantor**”) and BMO Harris, recorded with the USPTO on March 24, 2021 at Reel 007230 Frame 0855.

Pursuant to the Trademark Security Agreements, the undersigned Grantors previously granted to BMO Harris a continuing security interest in and continuing lien upon the trademarks and trademark applications set forth on **Schedule 1** attached hereto.

Pursuant to the Assignment of Loan Documents, dated as of the date hereof, between BMO Harris and SONOMA WINE 2000 DENMARK, LLC, a Delaware limited liability company (together with its successors and assigns, “**Lender**”), BMO Harris has assigned to Lender, and Lender has purchased from BMO Harris, all of BMO Harris’s right, title and interest in, among other things, the Trademark Security Agreements.


