## RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "**Release**") is made as of April 10, 2023 by MANUFACTURERS AND TRADERS TRUST COMPANY, as agent for itself and the other Secured Parties (as that term is defined in the Credit Agreement defined below) (together with its successors and assigns in such capacity, "**Agent**"), in favor of SERVICE ELECTRIC CABLEVISION, INC., a Pennsylvania corporation (together with its successors and assigns, "**Grantor**" and together with each Additional Grantor (as that term is defined in the Security Agreement defined below) and their successors and assigns, collectively, "**Grantors**").

WHEREAS, Grantor owns certain U.S. patents, trademarks, copyrights and tradenames, including the trademarks listed on the annexed Schedule A (collectively, the "**Intellectual Property**");

WHEREAS, Agent, Grantor, the Lenders (as that term is defined in the Credit Agreement defined below) and certain other parties entered into that certain Amended and Restated Credit Agreement dated as of January 21, 2011 and amended and restated as of January 19, 2018 (as amended prior to the date hereof, the "**Credit Agreement**"), pursuant to which the Lenders agreed to extend credit to Grantor on the terms and conditions described therein;

WHEREAS, Grantor, among others, is obligated to Agent pursuant to an Intellectual Property Collateral Agreement dated as of January 14, 2011 (as amended prior to the date hereof, the "**Security Agreement**") in favor of Agent;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on February 2, 2011, at Reel 4465 Frame 0708;

WHEREAS, pursuant to the Security Agreement, Grantor granted to Agent a security interest in all right, title and interest of Grantor in and to, among other things, the Intellectual Property, including the applications and registrations therefor, together with the goodwill of the business connected with the use of and symbolized by the Intellectual Property and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the "**Collateral**"), to secure the payment, performance and observance of the Secured Obligations, as defined in the Credit Agreement; and

WHEREAS, the Secured Obligations have been paid and performed in full and the Agent has agreed to terminate and release all of its right, title and interest in or to the Collateral, including the security interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien; Assignment. The Agent hereby (a) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges the security interest and any of its right, title and interest in or to the Collateral, whether granted pursuant to the Security

Agreement, (b) terminates the Security Agreement and (c) reassigns any and all interests it may have in such Collateral to the Grantor.

2. Authorization to Record. The Agent authorizes and requests that the USPTO record this Release.
