RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is made as of April 20, 2023, by Key Bank National Association, as the secured party ("Secured Party"), for the benefit of CAPL Retail LLC, as successor to the interests of debtors Lehigh Gas Wholesale Services, Inc., and each CST Brands Holdings, Inc., CST Brands Holdings 2, and LLC, Duane Manning Stores LLC as debtors by assignment (collectively "Debtors").


WHEREAS, reference is further made to that certain *Trademark Security Agreement*, dated as of October 30, 2012 (the "Security Agreement"), between Secured Party and Debtor Lehigh Gas Wholesale Services, Inc., which was recorded, among other places, with the United States Patent and Trademark Office at Reel 4893 Frame 0230;

WHEREAS, in connection with the Security Agreement, Debtor Lehigh Gas Wholesale Services, Inc. granted to the Secured Party a security interest in and to all of its right, title and interest in the Trademark Collateral (as defined in the Security Agreement) that included, without limitation the United States Trademark Registration No. 2061401 for the mark UNI-MART and design.

WHEREAS, Debtor Lehigh Gas Wholesale Services, Inc and/or its subsequent assignees have fully paid the indebtedness owing under the Security Agreement, and the Secured Party desires to release and discharge its security interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby releases any and all right, title and interest to their security interest in and to the Trademark Collateral, and reassign any and all interest it may have in such Trademark Collateral to current owner CAPL Retail LLC (assignee to original debtor Lehigh Gas Wholesale Services, Inc.
