TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS)

This TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS), dated as of April 21, 2023 (this “Termination and Release”), is granted by REGIONS BANK (“Lender”), in favor of DELTA FUEL COMPANY, L.L.C., a Louisiana limited liability company f/k/a Delta Fuel Company, Inc. (“Company”).

WHEREAS, pursuant to that certain Security Agreement (Trademarks) dated as of September 22, 2017, made by Company in favor of Lender (the “Security Agreement”), a security interest (the “Security Interest”) was granted in certain Property, and the Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on October 5, 2017, at Reel 006174, Frame 0305; and

WHEREAS, Lender now desires to terminate and release the entirety of its Security Interest in the Property.


NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Property pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Lender hereby agrees as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the meaning provided by reference in the Security Agreement.
2. Release of Security Interest. Lender hereby irrevocably terminates, releases and discharges the entirety of its Security Interest in the Property, and any right, title or interest Lender may have in such Property, including, without limitation, with respect to the Property listed on Schedule A attached hereto. To the extent Lender has acquired any right, title, or interest in the Property, Lender hereby irrevocably assigns to Company all such right, title, and interest.
3. Further Assurances. Lender hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, all at Company’s sole cost and expense.
4. Governing Law. This Termination and Release shall be governed by and construed in accordance with the laws of the State of Texas.
