NOW THEREFORE in consideration of the sum of US\$10 (ten dollars) to be paid by the Assignee to the Assignor, receipt of which is hereby acknowledged, the Assignor DOES HEREBY:

1. Assign to the Assignee all property, right, title and interest to the Trade Marks including any goodwill therein, and including the right to sue for damages and other remedies in respect of any infringement which may have occurred prior to the date of assignment.
2. Covenant to execute all documents, forms and authorizations and depose to or swear any declaration or oath as may reasonably be required for absolutely vesting full right, title and interest in the Trade Marks in favour of the Assignee.

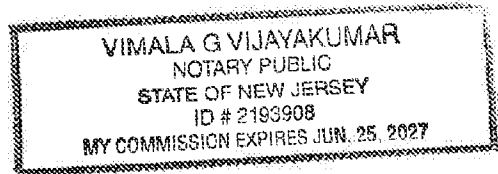
