This PLAN OF ENTITY CONVERSION (this "*Plan of Conversion*") is made as of the 20th day of December, 2022, by Clark Associates, Inc., a Pennsylvania corporation ("*CAI*").

The Board of Directors and the Stockholders of CAI deem that it is advisable and in the best interests of CAI and the Stockholders, that CAI be converted from a Pennsylvania corporation to a Pennsylvania limited liability company (the "*Conversion*") under the name "Clark Core Services, LLC", all in accordance with the provisions set forth in the Pennsylvania Business Corporation Law of 1988, as amended (the "*Act*") and this Plan of Conversion.

NOW, THEREFORE, CAI hereby agrees as follows:

- The Converting Association. The converting association is named "Clark Associates, Inc.", a Pennsylvania business corporation that was incorporated under the Act, with its registered office at 2205 Old Philadelphia Pike, Lancaster, PA 17602.
- The Converted Association. The converted association is named "Clark Core Services, LLC", a Pennsylvania limited liability company, with its registered office at 2205 Old Philadelphia Pike, Lancaster, PA 17602.
- The Conversion. Pursuant to the Act, CAI shall be converted from a corporation to a limited liability company. The terms of such conversion are set forth in this Plan of Conversion as well as the Certificate of Organization attached hereto as Exhibit A (the "*Certificate*").
- Procedures for Conversion. In order to effectuate the Conversion, CAI shall file with the Secretary of State of the Commonwealth of Pennsylvania (the "*Secretary*") (i) this Plan of Conversion, and (ii) the Certificate. CAI shall be converted from a corporation to a limited liability company effective as of the Effective Time (as defined below).
- Effective Time. The effective time and date of the Conversion (herein referred to as the "*Effective Time*") shall be 12:00:01 a.m. on December 31, 2022.
- Effects of the Conversion. At the Effective Time, CAI shall be converted from a corporation into a limited liability company, but shall be considered as the same entity for all legal and other purposes.
- Conversion of Stock to Membership Interests. In connection with the Conversion, each share of outstanding stock of CAI immediately prior to the Conversion shall convert into 100% membership interests after the Conversion, preserving the ownership proportion and relative rights, preferences and limitations of each such share.
