NOW THEREFORE, Assignor, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, DOES HEREBY irrevocably and unconditionally grant, sell, bargain, assign, transfer, convey and deliver to Buyer, its successors and assigns, all of Assignor’s right, title and interest free and clear of all Security Interests, in and to the Trademarks, together with the goodwill of the business connected with such Trademarks and any right to recover for past infringement of the Trademarks, TO HAVE AND TO HOLD without reservation and with all of the rights and appurtenances thereto belonging unto Buyer, for itself, its successors and assigns for their own use and behalf forever; and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to transfer the Trademarks to Buyer.


