**ARTICLES OF MERGER OF  
SUMITOMO (SHI) PLASTICS MACHINER (AMERICA), LLC  
AND VAN DORN DEMAG CORPORATION  
WITH AND INTO  
SUMITOMO (SHI) DEMAG PLASTICS MACHINERY NORTH AMERICA, INC.**


Pursuant to the provisions of Title 14, Chapters 2 and 11 of the Georgia Business Corporation Code and Sections 251,252 and 253 of the General Corporation Law of the State of Delaware, the undersigned hereby adopts the following Articles of Merger:


1. The names and states of incorporation of the constituent corporations in the merger are Sumitomo (SHI) Demag Plastics Machinery North America, Inc., a Georgia corporation, (sometimes herein referred to as "SHI America", "Parent" or the "Surviving Corporation"), Sumitomo (SHI) Plastics Machinery (America), LLC, a Georgia limited liability company (sometimes herein referred to as "SHI" or together with VDD, "Subsidiaries"), and Van Dorn Demag Corporation, a Delaware corporation (sometimes herein referred to as "VDD" or together with SHI, "Subsidiaries"), (SHI America, SHI and VDD are sometimes herein collectively referred to as the "Constituent Corporations"). SHI and VDD, both 100% wholly-owned Subsidiaries of SHI America, are being merged with and into SHI America. The name of the Surviving Corporation to the merger of SHI and VDD with and into SHI Plastics Machinery Inc. of America will be "Sumitomo (SHI) Demag Plastics Machinery North America, Inc."
2. The Agreement and Plan of Merger dated December 17, 2013, by and between SHI America, SHI and VDD (the "Merger Agreement") setting forth the terms and conditions of the merger has been approved, adopted, certified, executed by each of the Constituent Corporations in accordance with the provisions of the applicable provisions of the Georgia Business Corporation Code of the State of Georgia and the General Corporate Laws of the State of Delaware. The Articles of Incorporation of SHI America, as amended and in effect immediately prior to the effective time of the Merger, shall be the Articles of Incorporation of the Surviving Corporation until thereafter amended pursuant to applicable law.
3. A copy of the executed Merger Agreement is on file at the principal place of business of the Surviving Corporation, SHI America, which is located at 1266 Oakbrook Drive, Norcross, Georgia 30093-2238, ATTN: Mr. Mitsuru Terasaki, Chief Financial Officer.

4. A copy of the Merger Agreement will be furnished by SHI America as the Surviving Corporation, upon request and without cost, to any shareholder of either Constituent Corporation.
5. The approval of the shareholders of the Constituent Corporations was not needed to authorize the Merger Agreement.
6. Pursuant to the Merger Agreement, the merger of SHI into SHI America, shall be effective on December 31, 2013.


