**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 28, 2023 (“*Release*”), is made by **BYLINE BANK**, an Illinois banking corporation, as administrative agent and collateral agent for the Lenders (“*Agent*”), in favor of **PARKLINE, INC.**, a West Virginia corporation (“*Parkline*”), **PARKLINE FIELD SERVICES, LLC**, a West Virginia limited liability company (“*Parkline Services*” and together with Parkline, the “*Borrowers*,” and each individually, a “*Borrower*”), **PARKLINE PARENT COMPANY, INC.**, a Delaware corporation (“*Intermediate Holdings*”), **PARKLINE HOLDINGS, LLC**, a Delaware limited liability company (“*Parent*,” and together with Intermediate Holdings and the Borrowers, individually and collectively, “*Grantor*”), pursuant to that certain Security Agreement dated July 1, 2016 (as amended, modified, restated or supplemented from time to time, the “*Security Agreement*”).

WHEREAS, in connection with the Security Agreement, Grantor executed and delivered a certain Trademark Security Agreement, dated July 1, 2016 (the “*IP Security Agreement*”), which was recorded at the United States Patent and Trademark Office (“*USPTO*”) on July 1, 2016 at Reel 5825 and Frame 0407 (“*Notice*”), whereby Grantor granted to Agent a security interest in any and all of Grantor’s right, title, and interest in and to certain Trademarks, including the Trademarks listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent agrees as follows:


SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby irrevocably terminates the Notice and terminates, cancels, discharges, and releases the continuing security interest in Grantor’s right, title, and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the business symbolized by the Trademarks, granted pursuant to the IP Security Agreement and the Notice. Agent hereby authorizes the Grantor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Trademarks contemplated hereby. Agent agrees to execute and deliver to the Grantor all other instruments and other documents as the Grantor may reasonably request to release the security interest in the Trademarks which had been granted under the Notice at the sole expense of the Grantor.
