Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, as amended (the “**DGCL**”), the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is DTLR, Inc., a Maryland corporation (the “**Surviving Corporation**”), and the name of the corporation being merged into the surviving corporation is Sneaker Villa, Inc., a Delaware corporation (“**Merging Corporation**”); and together with the Surviving Corporation, the “**Constituent Corporations**”).

SECOND: A certain Agreement and Plan of Merger by and between the Surviving Corporation and the Merging Corporation (the “**Merger Agreement**”) has been approved, adopted, certified, executed and acknowledged by (i) the Surviving Corporation in accordance with Section 3-109 of the Maryland Corporations and Associations Law, as amended, and (ii) the Merging Corporation in accordance with Section 252 of the DGCL.

THIRD: The name of the Surviving Corporation is DTLR, Inc., a Maryland corporation.

FOURTH: The merger shall become effective on April 29, 2023 at 11:58 pm Eastern Time.

FIFTH: The Merger Agreement is on file at the principal office of the Surviving Corporation located at: 1300 Mercedes Drive, Hanover, Maryland 21076.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any stockholder of any of the Constituent Corporations.

SEVENTH: The Surviving Corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of any Constituent Corporation of the State of Delaware, as well as for enforcement of any obligation of the Surviving Corporation arising from the merger, and shall irrevocably appoint the Secretary of State as its agent to accept service of process in any such suit or other proceedings and the address to which a copy of such process shall be mailed to the Secretary of State is:
