## TRADemark ASSIGNMENT

This TRADE MARK ASSIGNMENT AGREEMENT (this “*Assignment*”) is made and entered into as of June 1, 2021 (“*Effective Date*”) by and between Lifefuels, Inc. (“*Assignor*”), and Infuze, LLC (“*Assignee*”) (each of Assignor and Assignee a “*Party*”, and collectively, the “*Parties*”).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:



Assignor hereby irrevocably and unconditionally assigns to Assignee, all of Assignor’s right, title, and interest in and to the Trade Marks, together with the goodwill of the business symbolized by the Trade Marks, as successor of the business to which the Trade Marks relate. Assignor further irrevocably and unconditionally assigns to Assignee the right to bring all claims for past, present, and future infringement, misappropriation, or other violation of the Trade Marks, including all rights to sue for and to receive and recover all profits and damages accruing from an infringement, misappropriation, or other violation as well as the right to grant releases for past infringements.
2. Assignor hereby requests the United States Patent and Trademark Office (USPTO), and any corresponding entities or agencies in any applicable jurisdictions, to record Assignee as the assignee and owner of the Trade Marks.
3. This Assignment Agreement shall be construed and interpreted in accordance with the laws of the State of Utah without giving effect to any principles of conflict of laws.


