**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT
(TRADEMARKS)**

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "**Release**") is effective as of the 1st day of May, 2023, by and between:

VKGS LLC, a Delaware limited liability company, having an address of 1045 North 115th Street, Suite 200, Omaha, Nebraska 68154 ("**Borrower**"), and

FIRST STATE BANK, having an address of 914 Lake Avenue, Gothenburg, Nebraska 69138 ("**Secured Party**").

W I T N E S S E T H:

A. Borrower and Secured Party, among others, entered into that certain Credit Agreement dated as of December 10, 2020 (as amended by that certain First Amendment to Credit Agreement dated as of December 15, 2022, and as further amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "**Credit Agreement**").

B. Borrower and Secured Party, among others, are parties to that certain Security Agreement dated as of December 10, 2020 (as the same may be amended from time to time, the "**Security Agreement**"), pursuant to which Borrower pledged, assigned and granted a security interest in favor of Secured Party in certain Collateral.

C. Borrower and Secured Party are parties to that certain Intellectual Property Security Agreement dated as of December 10, 2020, which was recorded with the United States Patent and Trademark Office ("**PTO**") on December 28, 2020, Reel 07199, Frame 0801 (the "**Trademarks Assignment**").

D. Borrower has satisfied all of the Secured Obligations under the Credit Agreement and the Security Agreement and requested that the Secured Party terminate and release its security interests in and liens on the Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) **Definitions.** All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement or the Security Agreement or the Trademarks Assignment, as the case may be.

2) **Termination and Release of Security Interest.** The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the Collateral, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Borrower, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Trademarks, effective as of the date set forth above.

IN WITNESS WHEREOF, the Secured Party has executed this Release effective as of the date written above.


