DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT IS MADE BETWEEN:

Assignor hereby sells, assigns, transfers, and sets over to Assignee all of Assignor's rights, title, and interest in and to the Marks and applications and registrations recited in the attached Schedule A, together with the goodwill of the business symbolized and associated with the Marks, and the right to sue for past infringements and unauthorized uses of the Marks.
2. Assignee hereby accepts such assignment and transfer.
3. Assignor does hereby authorize the empowered official of any country or countries whose duty it is to record trade mark and service mark registrations, applications and title thereto, to record the Marks and title thereto as the property of Assignee, its successors and assigns in accordance with the terms of this Assignment.
4. Assignor and its successors and assigns shall, without further compensation, perform such further acts and sign such documents as Assignee may reasonably request to fully effectuate this Assignment.
5. The parties hereto agree that this Assignment shall be governed by and construed and take effect in accordance with U.S. law and hereby submit to the exclusive jurisdiction of the U.S. Courts.
