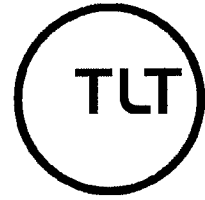

Between:

- (1) Shoo 634 Limited (company number 12527141) whose registered office is at 84 Grosvenor Street, London, W1K 3JZ (the "Assignor");
- (2) Warehouse Fashions Online Limited (formerly known as ~~Acraman 1874 Limited~~ (company number 12579412) whose registered office is at 49-51 Dale Street, Manchester, M1 2HF (the "Assignee")).

Background:

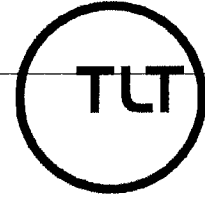
- (A) The Assignor and the Assignee are party to an assignment of trade marks dated ~~17th June 2020~~ (**Agreement**).
- (B) By mistake, the Agreement in a few places showed the name of the Assignor incorrectly as Shoo 643 Limited instead of Shoo 634 Limited.
- (C) The parties therefore wish to correct the Agreement as set out in this deed and to update the Agreement to record the change of name of the Assignee and the change in registered office of the Assignor.

It is agreed as follows:

- 1 Terms defined in the Agreement
- 1.1 Expressions defined in the Agreement and used in this deed have the meaning set out in the Agreement. The rules of interpretation set out in the Agreement apply to this deed.
- 2 Rectification
- 2.1 With effect from 17th June 2020 (**Rectification Date**), the parties agree to amend the Agreement as shown in the copy of the Agreement attached as the Schedule by replacing references to Shoo 643 Limited to Shoo 634 Limited.
- 3 Governing law
- 3.1 This deed and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.
- 4 Jurisdiction
- 4.1 Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this deed or its subject matter or formation.

This deed has been entered into on the date stated at the beginning of it.

Between:

- (1) Shoo 634 Limited (company number 12527141) whose registered office is at 84 Grosvenor Street, London, W1K 3JZ (the "**Assignor**"); and
- (2) Warehouse Fashions Online Limited (formerly known as ~~Acraman 1874 Limited~~) (company number 12579412) whose registered office is at 49-51 Dale Street, Manchester, M1 2HF (the "**Assignee**");

(each, a "**Party**", and together, the "**Parties**").

Background:

- (A) By the Warehouse Purchase Agreement (as defined below), the Assignor has agreed to assign to the Assignee such right, title and interest in and to the Trade Marks (as defined below) as the Assignor may have, and the Assignee has agreed to accept such assignment, on the terms set out in this Agreement.
- (B) Pursuant to and for the consideration set out in the Warehouse Purchase Agreement, and for and in consideration of the mutual promises and obligations set out in this Agreement, **it is agreed:**

1 Definitions and interpretation

1.1 In this Agreement, unless the context otherwise requires, the following words have the following meanings:

Act	has the meaning given to it in Clause 11;
Completion	has the meaning given to it in the Warehouse Purchase Agreement;
Completion Date	means the date of the Warehouse Purchase Agreement;
Warehouse Purchase Agreement	means the agreement for the sale and purchase of certain of the assets of the Assignors relating to the Warehouse brand, entered into on the date of this Agreement between (1) the Assignor; (2) the Assignee;
Trade Marks	means (a) the registered trade marks and applications for registration of trade marks listed in Schedule 1 (<i>Trade Marks</i>); (b) all registered trade marks and service marks, applications for registration of trade marks and service marks, and unregistered trade marks and service marks relating to the Warehouse brand and owned by any of the Assignor at the date of the Warehouse Purchase Agreement whether registered or not; and (c) all rights in goodwill attached to any of the items referred to under (a) or (b); and

1.2 The following rules of interpretation apply in this Agreement:

- 1.2.1 the singular includes the plural and vice versa and reference to any gender includes the other genders;

1.2.2 a "person" includes any individual, partnership, firm, bodies corporate, unincorporated associations, wherever incorporated or situate, and includes a reference to that person's legal representatives and successors;

1.2.3 words and phrases defined in the Companies Act 2006 or the Insolvency Act 1986 have the same meanings in this Agreement; and

1.2.4 a "**Clause**" or a "**Schedule**" is a reference to a clause of or schedule to this Agreement, and references within a Schedule to "paragraphs" are to paragraphs or sub paragraphs of that Schedule (unless the context states otherwise).

1.3 Where the words "include(s)", "including" or "in particular" are used in this Agreement, they are deemed to have the words "without limitation" following them.

1.4 Any reference to any statute or statutory instrument, or any section or part thereof, includes any enactment that has replaced or amended it or any instrument, order or regulation made under it that is now in force and also includes any past statutory provisions which such provision has directly or indirectly replaced.

1.5 This Agreement shall be binding on, and enure to the benefit of, the parties to this Agreement and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.

1.6 Headings are for reference purposes only and shall not affect the construction of anything in this Agreement.

1.7 The Schedules shall be treated as an integral part of this Agreement and references to this Agreement shall include the Schedules.

2 **Assignment**

2.1 Pursuant to the Warehouse Purchase Agreement the Assignor hereby absolutely and irrevocably assigns to the Assignee, and the Assignee hereby accepts the assignment of, all of the Assignor's right, title and interest in and to the Trade Marks, including to the extent owned by the Assignor:

2.1.1 all statutory and common law rights attaching to the Trade Marks including any goodwill attaching to the Trade Marks;

2.1.2 entitlement to any registrations granted pursuant to any of the applications comprised in the Trade Marks;

2.1.3 the right to file any applications based on any of the Trade Marks; and

2.1.4 any rights arising from ownership of any of the Trade Marks, including all rights to bring, make, oppose, defend and appeal proceedings, claims or actions, and to recover and retain damages in respect of any infringement, or any other cause of action arising from ownership, of the Trade Marks.

in each case for the whole term of protection including any renewals, reversions, revivals and extensions

3 **Warranties**

3.1 Save for the warranty given in Clause 3.2, all warranties, representations, conditions and other terms implied by statute, at common law, on the basis of usage, custom or the Parties' previous course of dealings, in fact or otherwise, are hereby excluded to the fullest extent permitted by law.

3.2 The Assignor warrants that during its period of ownership:

- 3.2.1 it has not given any third party permission to use any Trade Mark or otherwise licensed or assigned any of its rights under the Trade Marks;
- 3.2.2 all application, registration, renewal and other fees of which Seller has been notified by Fieldfisher LLP in respect of each of the Trade Marks have been paid when due;

- 3.2.3 it has not knowingly acquiesced in the unauthorised use of any Trade Mark by a third party;
- 3.2.4 it is unaware of any infringement of any Trade Mark by a third party; and
- 3.2.5 save as set out in the Warehouse Purchase Agreement, no claim has been made by a third party that challenges the right of the Assignor to use any Trade Mark, and it is unaware of any circumstances which would give rise to a claim.

4 Recordal of the Assignment

Except to the extent prohibited or required otherwise by applicable law, the Assignee shall be solely responsible, at its own cost and expense, for all recordals of the assignments made under this Agreement, including all filings and other actions required to make such recordals, and all costs and expenses incurred in connection therewith, including filing and counsel fees.

5 Further Assurance

- 5.1 The Assignor shall, at the Assignee's written request and expense, promptly do, execute and deliver (or procure to be done, executed and delivered including by any necessary third party) all such further acts, documents and things reasonably required by the Assignee in order to give full effect to this Agreement, including for assisting the Assignee with the recordal of the assignment of the Trade Marks assigned by the Assignor under this Agreement, but in each case only to the extent that such acts, documents or things cannot be done or executed by the Assignee or, if they can be done or executed by the Assignee, to the extent they would not be sufficient to achieve the purposes of giving full effect to this Agreement, including the recordal of the assignments of the Trade Marks assigned by the Assignor under this Agreement.
- 5.2 The Assignor shall do the following at the Assignee's cost and direction, pending formal registration or recordal of the assignment of the Trade Marks to the Assignee:
 - 5.2.1 if legally required to do so, pay all applicable application, filing, registration, renewal and other fees as they fall due;
 - 5.2.2 if legally required to do so, promptly satisfy all official actions issued by any relevant trade mark registry or authority;
 - 5.2.3 provide the Assignee with all information and other assistance reasonably required to enable the Assignee to prepare, file or prosecute applications for registration of any of the Trade Marks (including producing, in the appropriate form, any evidence of its use of the Trade Marks);
 - 5.2.4 provide the Assignee with all information and other assistance reasonably required by the Assignee to conduct, defend or settle any relevant claims, actions or proceedings (including, if requested by the Assignee, bringing proceedings in its own name or lending its name to any proceedings brought by the Assignee).
- 5.3 The Assignor appoints the Assignee to be its attorney in his name and on its behalf to execute documents, use the Assignor's name and do all things which are necessary or desirable for the Assignee to obtain for itself or its nominee the full benefit of this Agreement. This power of attorney is irrevocable and is given by way of security to secure the performance of the Assignor's obligations under this Agreement and the proprietary interest of the Assignee in the Trade Marks and so long as such obligations of the Assignor remain undischarged, or the

Assignee has such interest, the power may not be revoked by the Assignor, save with the consent of the Assignee.

5.4 Without prejudice to clause 5.3, the Assignee may, in any way it thinks fit and in the name and on behalf of the Assignor:

5.4.1 take any action that this Agreement requires the Assignor to take;

5.4.2 exercise any rights which this Agreement gives to the Assignor; and

5.4.3 appoint one or more persons to act as substitute attorney(s) for the Assignor and to exercise such of the powers conferred by this power of attorney as the Assignee thinks fit and revoke such appointment.

5.5 The Assignor undertakes to ratify and confirm everything that the Assignee and any substitute attorney does or arranges, or purports to do or arrange, in good faith in exercise of any power granted under this clause.

6 Confirmatory Assignment

If in any country or territory the execution after the date of this Agreement of a confirmatory assignment or other document of any of the Trade Marks in that country or territory would be ineffective or invalid by reason of the transfer effected by this Agreement, then this Agreement shall be deemed to be an agreement to assign, and not an assignment of the relevant Trade Marks in that country or territory.

7 Severance

If any provision of this Agreement is or becomes illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision shall be deemed to be severed from this Agreement and the Parties shall replace such provision with one having an effect as close as possible to the deficient provision. The remaining provisions will remain in full force in that jurisdiction and all provisions will continue in full force in any other jurisdiction.

8 Variations

No variation of this Agreement shall be effective unless it is made in writing and signed by or on behalf of each of the Parties.

9 Waivers and Remedies

9.1 No waiver of any right or remedy under this Agreement shall be effective unless given in writing. Unless expressly stated otherwise, a waiver shall be effective only in the circumstances for which it is given.

9.2 No delay or omission by any Party in exercising any right or remedy provided by law or under this Agreement shall constitute a waiver of such right or remedy.

9.3 The single or partial exercise of a right or remedy under this Agreement shall not preclude any other nor restrict any further exercise of any such right or remedy.

10 Costs and Expenses

Except as provided otherwise, each Party shall pay its own costs and expenses in connection with the negotiation, preparation and performance of this Agreement.

11 Rights of Third Parties

A person who is not a party to this Agreement shall have no rights under the Contracts (Rights of Third Parties) Act 1999 ("Act") to rely upon or enforce any term of this Agreement, provided that this does not affect any right or remedy of the third party that exists or is available apart from that Act. No Party may declare itself as a trustee of the rights under this Agreement for the benefit of any third party save as expressly provided in this Agreement.

12 Entire Agreement

- 12.1 This Agreement, together with any other documents referred to in it, constitutes the whole agreement between the Parties relating to the subject matter of this Agreement at the date of this Agreement to the exclusion of any terms implied by law which may be excluded by contract and supersedes any previous written or oral agreement between the Parties in relation to the matters dealt with in this Agreement.
- 12.2 Each Party acknowledges that, in entering into this Agreement, it is not relying on any representation, warranty or undertaking not expressly incorporated into it.
- 12.3 A Party's only right or remedy in relation to any provision of this Agreement shall be for breach of this Agreement and no Party shall have any right or remedy in respect of misrepresentation (whether negligent or innocent and whether made prior to and/or in this Agreement).
- 12.4 Nothing in this Clause 12 limits or excludes any liability for fraud.

13 Dealing with Rights and Obligations

- 13.1 No Party may assign, transfer, create any trust over, charge or otherwise encumber or deal in any other manner with all or any of its rights and obligations under this Agreement (including any cause of action arising in connection with it) without the prior written consent of the other Parties. Any such purported action shall be ineffective.

14 Counterparts

This Agreement may be executed in counterparts, and shall be effective when each Party has executed a counterpart. Each counterpart shall constitute an original of this Agreement, but all the counterparts shall together constitute one and the same instrument.

15 Governing Law and Jurisdiction

- 15.1 This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including any non-contractual obligations, disputes or claims) is governed by and shall be construed in accordance with English law.
- 15.2 Each of the Parties irrevocably agrees that the courts of England shall have exclusive jurisdiction to settle any dispute or claim which may arise out of or in connection with this Agreement and that accordingly any proceedings arising out of or in connection with this Agreement or its subject matter or formation shall be brought in such courts. Each of the Parties irrevocably submits to the jurisdiction of such courts and waives any objection to proceedings in any such court on the ground of venue or on the ground that the proceedings have been brought in an inconvenient forum.
- 15.3 Each of the Parties agrees that in the event of any action between any of the Parties being commenced in respect of this Agreement or any matters arising under it, the process by which it is commenced (where consistent with the applicable court rules) may be served on them in accordance with Clause 14 of the Warehouse Purchase Agreement save that email service will be excluded from any legal process or proceedings under this Clause 15.3.

This Agreement has been entered into by the Parties on the date first above written.
