IP ASSIGNMENT AGREEMENT

This IP Assignment Agreement (this "Assignment") is made and entered into as of January 24, 2019 ("Effective Date") by and between ID Agent LLC, a Delaware limited liability company ("Assignor"), and Kaseya Limited, a private company limited by shares incorporated and existing under the laws of Ireland ("Assignee").

WHEREAS, pursuant to that certain Unit Purchase Agreement, dated as of January 24, 2019, by and among Assignor, Assignee and the other Persons party thereto (the "Purchase Agreement"; capitalized terms used but not defined herein shall have the meaning ascribed therein), Assignor has agreed to irrevocably sell, assign, transfer, convey and deliver to Assignee Assignor's entire right, title and interest in and to all Intellectual Property owned or purported to be owned by Assignor, including, without limitation, (a) the Company's products and services, including, without limitation, (i) all related unregistered trademarks and trade names, (ii) the current and all prior versions of the Dark Web ID and Spotlight ID software programs, in any and all forms (including source code) and media, and (iii) all documentation therefor and trade secrets and unregistered copyrights embodied therein, and (b) the other Intellectual Property listed or otherwise described on Schedule A hereto (collectively, the "Assigned IP"); and

WHEREAS, the Assignor is the owner of all right, title, and interest in and to the Assigned IP.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein and in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and Assignee hereby agree as follows:

1. Assignor does hereby irrevocably sell, convey, assign, transfer and deliver to Assignee, its successors and assigns, and the Assignee purchases and accepts from the Assignor, all of Assignor's right, title and interest in and to (a) the Assigned IP, including all common-law rights therein or related thereto and the goodwill of the business symbolized thereby, and (b) all other Intellectual Property that is owned by Assignor and used or held for use in or necessary for the conduct of the Business, together with (c) the right to apply for and obtain registrations and renewals for the foregoing, and (d) the right to bring any action, claim or proceeding for the infringement, misappropriation, dilution or unauthorized use of any of the foregoing accruing or occurring at any time prior to, on or after the Effective Date and to retain all monies and proceeds therefrom ((a) through (d) collectively, the "Assigned Rights"). The Assignor further consents to recordation of this Assignment by the Assignee, including with the United States Patent and Trademark Office or similar foreign offices.

2. Assignee shall hold the Assigned Rights for its and its successors' and assigns' enjoyment, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made. All representations, warranties and indemnities with respect to the Assigned Rights shall be applied solely as set forth in the Purchase Agreement, and none are contained in this Assignment.

3. At any time and from time to time upon the request of Assignee, Assignor shall take all actions that are required to vest, effect, record and perfect ownership of the Assigned Rights with Assignee. Without limiting the generality of the foregoing, Assignor shall, at Assignee's written request, cooperate reasonably promptly with Assignee to effect a transfer of all registrations, accounts, account administrators, registrar contacts and contact information for the domain names and social media identifiers on Schedule A to persons or entities designated by Assignee.

4. This Assignment may be signed in counterparts (including by facsimile or PDF), each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.

5. This Assignment shall be governed by and be construed in accordance with the domestic Laws of the State of Delaware, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than the State of Delaware.

6. This Assignment may not be supplemented, altered or modified in any manner except by a writing signed by both parties hereto.

7. This Assignment shall bind and shall inure to the benefit of the respective parties and their assigns, transferees, and successors.

8. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but both of which together will constitute one and the same instrument. This Assignment may be executed by facsimile, photo, or electronic signature and such facsimile, photo, or electronic signature shall constitute an original for all purposes.
