**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This Termination and Release of Security Interest in Patents and Trademarks (“IP Release”) is made as of May 4, 2023, 2023, by **MidCap Funding IV Trust**, a Delaware statutory trust (“Agent”) in favor of **TissueTech, Inc.**, a Florida corporation (the “Grantor”).

WHEREAS, the Grantor is subject to that certain Intellectual Property Security Agreement dated April 8, 2022 in favor of Agent recorded by the United States Patent and Trademark Office at Reel 7725, Frame 0580 for trademarks and at Reel 60116, Frame 0468 for patents.

WHEREAS, Agent received, under the terms of the Intellectual Property Security Agreement, a continuing security interest (the “Security Interest”) in (i) the patents set forth on Exhibit A attached hereto, (ii) the trademark CLIRADDEX including the registration set forth on Exhibit B attached hereto including the goodwill of the business of Grantor connected with and symbolized by such trademarks, and (iii) any and all claims for damages by way of past, present and future infringements of any of the rights included in (i) or (ii), above, with the right, but not the obligation to sue for and collect such damages for said use or infringement or the intellectual property rights identified above, (iv) all licenses or other rights to use any of the rights in (i) or (ii), above, (v) all amendments, extensions, and renewals of any of (i) or (ii), above, (vi) all proceeds and products of (i) or (ii), above, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing ((i) through (vi), collectively, the “Released Collateral”).

WHEREAS, the Agent has agreed to terminate and release its security interest in all the Released Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges the Security Interest in the Released Collateral.


