**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 5, 2023 (“**Release**”), is made by White Oak Healthcare Finance, LLC, as administrative agent for the lenders (herein, “**Grantee**”) in favor of each of United Medical Systems (DE), Inc., a Delaware corporation, American Kidney Stone Management, Ltd., an Ohio limited liability company, and AKSM Medical Ventures, Inc., a Delaware corporation (collectively, “**Grantor**”):

**WHEREAS**, in connection with one or more loan and security agreements, Grantors have executed and delivered to Grantee that certain Intellectual Property Security Agreement, dated March 12, 2019 (the “**IP Security Agreement**”), which was recorded at the United States Patent and Trademark Office (“**USPTO**”) on March 12, 2019 at Reel 6588 and Frame 0589, whereby Grantors granted to Grantee a security interest in any and all of Grantors’ right, title, and interest in and to certain Trademarks, including the Trademarks listed on Schedule A attached hereto.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee agrees as follows:


**SECTION 1. Defined Terms**. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

**SECTION 2. Termination and Release**. Grantee, without representation, warranty, or recourse, hereby irrevocably terminates the IP Security Agreement and terminates, cancels, discharges, and releases the continuing security interest in Grantor’s right, title, and interest in and to the Trademarks, all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing, in each case granted pursuant to the IP Security Agreement. Grantee hereby authorizes each Grantor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Trademarks contemplated hereby.
