TRADEMARK ASSIGNMENT AND ASSUMPTION AGREEMENT

This Trademark Assignment and Assumption Agreement (this “**Assignment**”) is effective as of May 2, 2023 by and between the following parties:

Assignor: The Font Bureau, Inc., a Massachusetts corporation with a principal place of business at 71 Red Pony Road, West Tisbury, MA 02575.

Assignee: Monotype Imaging Inc., a Delaware corporation, with a principal place of business at 600 Unicorn Park Drive, Woburn, MA 01801.

WHEREAS, Assignor has adopted, used and is using and is the owner of the marks and trademark applications and registrations on Schedule A (hereinafter the “**Trademarks**”), and

WHEREAS, the parties have entered into an Asset Purchase Agreement dated as of the date hereof (the “**Purchase Agreement**”) pursuant to which Assignor transferred, sold and conveyed to Assignee certain assets of Assignor, including the Trademarks;

WHEREAS, Assignor now wishes to assign the Trademarks to Assignee, and Assignee is desirous of acquiring the Trademarks from Assignor; and

WHEREAS, the execution and delivery of this Assignment is a condition to Closing (as defined in the Purchase Agreement) under the Purchase Agreement.


NOW, THEREFORE, in consideration of the premises set forth above and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. **Assignment.** Assignor hereby sells, assigns, conveys, and transfers to Assignee and its successors, assigns, and legal representatives, Assignor’s entire right, title and interest (legal and equitable) to the Trademarks, together with the goodwill of the business symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement, violation or unauthorized use of the Trademarks, along with the right to sue for past, present and future infringements, violations or unauthorized uses of the same and collect same for Assignee’s sole use and enjoyment.
2. **Authorization to Record Assignment.** Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, assigns or legal representatives in accordance with the terms of this instrument.


3. **Further Assurances.** Assignor must execute all such further documents and do all such further acts as Assignee may reasonably request to perfect the assignments contemplated by this document.
4. **Counterparts.** Assignee and Assignor also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Assignee and Assignor.
5. **Successors and Assigns.** This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
