TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination and Release"), dated as of April 14, 2023 is entered into by JEFFERIES FINANCE LLC, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties in favor of MILLER'S ALE HOUSE, INC., a Delaware corporation (the "Grantor"). Capitalized terms used herein but not otherwise defined herein have the meanings assigned to them in the Security Agreement (as defined below), whether directly or by reference to another agreement.

WITNESSETH:

WHEREAS, reference is made to the Credit Agreement dated as of May 30, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Credit Agreement"), among MAH HOLDING CORPORATION ("Parent"), ALE HOUSE HOLDINGS, INC. ("Holdings"), the Grantor, the Lenders party thereto from time to time, JEFFERIES FINANCE LLC, as administrative agent, and the other parties party thereto;

WHEREAS, pursuant to (i) that certain Security Agreement dated as of May 30, 2018 (the "Security Agreement"), by and among Parent, Holdings, the Grantor, each Subsidiary of the Grantor from time to time party thereto and the Collateral Agent, (ii) that certain Notice of Grant of Security Interest in Trademarks dated as of May 30, 2018 by and between the Grantor and the Collateral Agent and (iii) that certain Notice of Grant of Security Interest in Copyrights, dated as of May 30, 2018 by and between the Grantor and the Collateral Agent, the Grantor granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the "Security Interest") in certain Intellectual Property of the Grantor, including the Trademarks shown on Schedule I attached hereto, and all Proceeds and products of the foregoing (collectively, the "Trademark Collateral") and the Copyrights shown on Schedule II attached hereto, and all Proceeds and products of the foregoing (collectively, the "Copyright Collateral");

WHEREAS, a Notice of Recordation of Assignment Document for the Trademark Collateral was recorded in the Trademark Division of the United States Patent and Trademark Office on June 12, 2018 at Reel/Frame 6395/0501;

WHEREAS, a Certificate of Recordation was recorded in the United States Copyright Office on June 11, 2018 at Volume 9969, Doc. No. 772; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral and the Copyright Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent, without representation, warranty or recourse, hereby (i) terminates, releases and discharges the Security Interest in the Trademark Collateral, (ii) terminates, releases and discharges the Security Interest in the Copyright Collateral and (iii) assigns, conveys and transfers to the Grantor any and all of the rights, titles or interests of the Collateral Agent in the Trademark Collateral and Copyright Collateral.

The Collateral Agent authorizes the Grantor and any successor to the Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademarks or the Copyrights) and their respective counsel to record this Termination and Release with the United States Patent and Trademark Office or the United States Copyright Office, or any other applicable governmental authority at the Grantor's expense.

This Termination and Release shall be governed by, and construed in accordance with, the laws of the State of New York.
