TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”), is dated as of May 5, 2023, and made by **PNC BANK, NATIONAL ASSOCIATION** (the “Grantee”), to **CLOVER TECHNOLOGIES GROUP, LLC**, a Delaware limited liability company (the “Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 1, 2020, made by Grantor in favor of Grantee (the “Security Agreement”), a security interest was granted by the Grantor to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on October 1, 2020, at Reel/Frame 7066/0586;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge all of its right, title and security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Grantee hereby states as follows:

1. Definitions. The term “Intellectual Property,” as used herein, shall mean all of Grantor’s right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in all of the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in and to the Intellectual Property and the related registrations and goodwill, effective as of the date set forth above.



