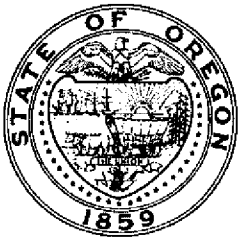
1. I am counsel for DLF USA Inc. ("DLF") and submit this Affidavit based on personal knowledge of the facts contained herein.

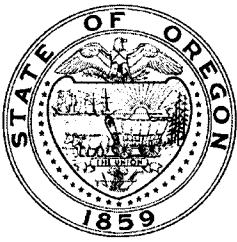
