RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (the “Release”) is dated as of May 8, 2023 and made by ANTARES CAPITAL LP, as administrative agent and as collateral agent (together with its successors in such capacities, the “Agent”) for the Secured Parties (as defined in the Credit Agreement) in favor of SIGNANT HEALTH GLOBAL LLC (f/k/a BRACKET GLOBAL LLC), a Delaware limited liability company, CLINAPPS, INC., a California corporation, SIGNANT HEALTH LLC (f/k/a CRF INC.), a Delaware limited liability company, ENTRA HEALTH SYSTEMS LLC, a California limited liability company, and MOTENTIA, LLC, a Virginia limited liability company (each, a “Grantor”).

WITNESSETH

WHEREAS, Bracket Intermediate Holding Corp., a Delaware corporation, the parties party thereto from time to time, and the Agent entered into that certain First Lien Credit Agreement, dated as of November 25, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and the Grantors and the Agent entered into that certain First Lien Pledge and Security Agreement, dated as of November 25, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered to the Agent that certain First Lien Intellectual Property Security Agreement, dated as of November 25, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Agreement”) and recorded with the United States Patent and Trademark Office on November 25, 2020 at Reel/Frame Nos. 7115/0429, 7115/0496, 7115/0536, 7115/0506, and 7115/0524, pursuant to which each Grantor granted to the Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a security interest in all of its right, title and interest in and to all of the IP Collateral (as defined in the Agreement);

WHEREAS, the Grantors have requested that the Agent release its security interest in all of its right, title and interest in and to all of the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to all of the IP Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the IP Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that Agent may have obtained in, to and under the IP Collateral under the Security Agreement and the Agreement.




