TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is between FHS, Inc., a corporation organized under the laws of the State of South Carolina and having an address of 1924 W. NOW, THEREFORE, Assignor, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby irrevocably assigns, transfers, grants and conveys to Assignee, free and clear of all pledges, security interests, liens, charges, encumbrances, equities, claims, options or limitations of any kind, all of Assignor's worldwide right, title and interest in, to and under the Trademarks, including all common law rights related thereto, together with the goodwill of the business associated therewith and which is symbolized thereby, including all rights to sue for infringement thereof, whether arising on, prior to or subsequent to the date of this Assignment, and any and all applications for registration, registrations, renewals and extensions thereof that currently exist, including the U.S. Trademark Registrations referenced above and all renewals thereof, or that may hereafter be secured under the laws of the United States and in any other jurisdiction, including any and all Convention and Treaty rights, such as rights of priority, the same to be held and enjoyed by Assignee, its successors and assigns from and after the date hereof.

Assignor agrees to execute, acknowledge and deliver to Assignee, at Assignee's request, any and all further documents, papers, affidavits, statements and/or other instruments, whether or not in paper or electronic form, to confirm Assignee's ownership of all rights pursuant to this Assignment.

This Assignment shall be binding upon the successors and assigns of Assignor and inure to the benefit of the successors and assigns of Assignee.
