TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is entered into as of April 24, 2023, (the "Effective Date") by and between JUDITH GAUL NYQUIST (formerly known as Judith Alaine Gaul), a United States citizen, with an address at 35 Village Way, Malvern, PA 19355 ("Assignor"), and FLOWER CITY TISSUE MILLS COMPANY, INC., a corporation formed under the laws of the State of New York, with an address at 700 Driving Park Avenue, Rochester, New York 14613 ("Assignee"). NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. **Assignment.** Assignor hereby assigns to Assignee all of Assignor's right, title, and interest in and to the Trademarks and the goodwill attached to and symbolized by the Trademarks, including without limitation all rights in and to US Reg. 1,239,367 WRAPTURES issued May 24, 1983, as well as the right to sue for, and recover damages with respect to, any past, present, and future infringements of the Trademarks. Assignee hereby agrees to record a copy of this Assignment with the US Patent & Trademark Office at Assignee's sole expense.

2. **Counterparts.** This Agreement may be executed and delivered by facsimile or electronic mail signature and in multiple counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
