**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of May 8, 2023 (this “Release”) is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as administrative agent (the “Administrative Agent”) under that certain Second Lien Intellectual Property Security Agreement, dated as of September 5, 2018, executed by Clinapps, Inc., a California corporation, Signant Health Global LLC, a Delaware limited liability company, Motentia, LLC, a Virginia limited liability company, Signant Health LLC, a Delaware limited liability company, and Entra Health Systems LLC, a California limited liability company (each a “Grantor”), in favor of the Administrative Agent, for the benefit of the Lenders (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), in favor of each Grantor. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement, the Credit Agreement or the Security Agreement referenced in the Trademark Security Agreement, as applicable.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office (the “USPTO”) on September 11, 2018 at Reel 6434, Frame 0141, the Grantors granted to the Administrative Agent, for the benefit of the Lenders, a security interest in, on and to all of each Grantor’s right, title and interest in all of the Trademarks owned by such Grantor and constituting Collateral, including the United States registered trademarks and trademark applications set forth on the attached Schedule 1 (the “Trademark Collateral”); and

WHEREAS, pursuant to that certain Payoff Letter, dated as of even date herewith, by and among the Grantors, the Administrative Agent and certain other parties party thereto, each Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the USPTO evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate and cancel the Trademark Security Agreement, (b) terminate the security interest created under the Trademark Security Agreement in the Trademark Collateral, including without limitation the United States registered trademarks and trademark applications set forth on the attached Schedule 1, (c) release its security interest in the Trademark Collateral, (d) discharge any and all rights, title and interest it has in the Trademark Collateral, and (e) reassign, grant, and convey all rights and interests Administrative Agent may have in the Trademark Collateral to the Grantors.



Administrative Agent authorizes and requests that the Commissioner of Trademarks of the USPTO and any other applicable government officer record this Release.
