**TERMINATION AND RELEASE OF
TRADEMARK SECURITY INTEREST**

This Termination and Release of Trademark Security Interest (this "Release") dated this 3rd day of March 2023 (the "Effective Date") is made by Horizon Funding I, LLC ("HFI"), Powerscourt Investments XXV Trust (collectively with HFI, "Lender") and Horizon Technology Finance Corporation ("Collateral Agent").

WHEREAS, pursuant to the Venture Loan and Security Agreement dated July 2, 2021 between Lender, Collateral Agent, Reputation Institute, Inc. ("Borrower"), Reputation Institute Holding A/S ("Reputation A/S"), Reputation Institute ApS ("Reputation ApS") and RepTrak Holdings, Inc. (collectively with Borrower, Reputation A/S and Reputation ApS, "Loan Parties"), Lender and Collateral Agent were granted a security interest in certain assets of the Loan Parties, including, without limitation, Borrower's trademarks; and

WHEREAS, Borrower has received a United States trademark registration for the trademark PURPOSE POWER INDEX, Registration Number 6,352,804 (the "Mark");

WHEREAS, Borrower has requested that Lender and Collateral Agent terminate and release their security interest in the Mark in connection with Borrower's transfer of ownership of the Mark to an unaffiliated third party, StrawberryFrog, LLC (the "Transferee");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Collateral Agent agrees as follows:

1. Termination and Release. Lender and Collateral Agent: (a) release and terminate all of their right, title and interest in and to the Mark, including all goodwill associated with the Mark; and (b) agree that all security interest in the Mark is discharged, terminated and released.

2. Filing with PTO. Lender and Collateral Agent consent to Borrower or Transferee, or their respective successors or assigns, filing or recording this Release with the United States Patent and Trademark Office (the "PTO"), as may be necessary. The PTO is authorized to receive and record this Release with the same authority as if Lender or Collateral Agent would have recorded the Release itself.




