TRADE MARK ASSIGNMENT DEED

THIS DEED is entered into on the 30 March 2023 (the “**Effective Date**”) by and between:

(1) **DANNY WILSON**, an Australian citizen, of 2 Brooks Reach Road, HORSLEY, NSW, 2530:

(2) **SYLVIA WILSON**, an Australian citizen, of 2 Brooks Reach Road, HORSLEY, NSW, 2530,

(together, the “**Assignors**”)

AND

(3) **WHO YA GONNA CALL BARK BUSTERS PTY LTD** (ACN 056 484 103), a company registered in New South Wales, whose principal place of business is at of 2 Brooks Reach Road, HORSLEY, NSW, 2530 (the “**Assignee**”),

each a “**Party**”, and collectively, the “**Parties**”.

NOW, THEREFORE, in consideration of the following terms and conditions, the Parties agree as follows:

1 DEFINITIONS

In this Deed, the following words and phrases that have their first letter(s) capitalised have the meaning ascribed to them below:

“**Deed**” means this Trade Mark Assignment Deed;

“**Effective Date**” means the date written at the head of this Deed or where no such date is added, the date on which the last party to this Deed executes the Deed;

“**Trade Mark Registrations**” means the registrations and applications set out in Schedule 1; and

“**Trade Marks**” means the trade marks shown in the Trade Mark Registrations.

2 ASSIGNMENT

The Assignors hereby transfer all right, title and interest they have in and to the Trade Marks (including any copyright) and Trade Mark Registrations to the Assignee, including:

2.1 the right to take action against any past infringements of the Trade Marks and Trade Mark Registrations;

2.2 any copyright in any of the Trade Marks;

2.3 any goodwill or reputation the Assignor has in and to any of the Trade Marks; and

2.4 any goodwill or reputation the Assignor has in and to any of the Trade Marks, including in Australia, the right to take action for passing off or misleading and deceptive conduct under s18 of Schedule 2 of the *Competition and Consumer Act 2010* (Cth).

3 ENTIRE DEED

This Deed sets out the entire Deed of the Parties in relation to the subject matter of this Deed and shall supersede all previous communications between the Parties, either oral or written in relation to the subject matter of this Deed.

4 VARIATION

Unless otherwise specified in this Deed, no change, alteration or amendment of this Deed shall bind either Party unless made in writing bearing the signature of a duly authorised representative of each Party.

5 SEVERENCE

If any provisions of this Deed should become fully or partially invalid or unenforceable for any reason whatsoever, or violate any applicable law, such provisions shall be deleted from this Deed, and the remainder of this Deed, to the extent permissible, shall be valid and binding as if such provision(s) were not included herein.

6 COUNTERPARTS

6.1 This Deed may be executed in any number of counterparts and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

6.2 Any signature page delivered by facsimile machine or electronic mail (including any pdf format) shall be binding to the same extent as an original signature page.


7 LAW AND JURISDICTION


