RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST** (this “Release”) is made as of April 25, 2023 (“Effective Date”) by Crescent Direct Lending, LLC (the “Grantee”), in favor of, as applicable, Hub Pen Company, LLC, a Delaware limited liability company (“Hub Pen”), Best Promotions, LLC, a Delaware limited liability company (“Best Promotions”), HandsStands Promo, LLC, a Utah limited liability company (“HandsStands”), Beacon Promotions, Inc., a Minnesota corporation (“Beacon Promotions”), Forty Four Group, LLC, a California limited liability company (“Forty Four”), Debco Bag Distributors ULC, a British Columbia unlimited liability company (“Debco Bag”) and Webb Business Promotions, Incorporated, a Minnesota corporation (“Webb Business” and collectively with Hub Pen, Best Promotions, HandsStands, Beacon Promotions, Forty Four and Debco Bag, each a “Grantor” and together the “Grantors”).

WHEREAS, the Grantors and Grantee are parties to that certain Guarantee and Collateral Agreement, dated as of March 23, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”) executed in order to secure the prompt and complete payment, observance and performance of all of the Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of March 23, 2016, by and between the Grantee and Hub Pen (the “Hub Pen 2016 Security Agreement”), that certain Trademark Security Agreement, dated as of November 15, 2017, by and between the Grantee and Hub Pen (the “Hub Pen 2017 Security Agreement”) and that certain Trademark Security Agreement, dated as of June 13, 2018, by and between the Grantee and Hub Pen (the “Hub Pen 2018 Security Agreement”), Hub Pen granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest in all right, title and interest of Hub Pen in and to certain intellectual property, (ii) that certain Trademark Security Agreement, dated as of November 15, 2017, by and between the Grantee and Best Promotions (the “Best Promotions Security Agreement”), Best Promotions granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest in all right, title and interest of Best Promotions in and to certain intellectual property, (iii) that certain Trademark Security Agreement, dated as of December 21, 2018, by and between the Grantee and HandsStands (the “HandsStands Security Agreement”), HandsStands granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest in all right, title and interest of HandsStands in and to certain intellectual property, (iv) that certain Trademark Security Agreement, dated as of December 21, 2018, by and between the Grantee and Beacon Promotions (the “Beacon Promotions Security Agreement”), Beacon Promotions granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest in all right, title and interest of Beacon Promotions in and to certain intellectual property, (v) that certain Trademark Security Agreement, dated as of September 14, 2018 by and between the Grantee and Forty Four (the “Forty Four Security Agreement”), Forty Four granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest in all right, title and interest of Forty Four in and to certain intellectual property, (vi) that certain Trademark Security Agreement, dated as of June 13, 2018 by and between the Grantee and Debco Bag (the “Debco Bag Security Agreement”), Debco Bag granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest

in all right, title and interest of Debco Bag in and to certain intellectual property and (vii) that certain Trademark Security Agreement, dated as of October 16, 2020, by and between the Grantee and Webb Business (the “Webb Business Security Agreement”, together with the Hub Pen 2016 Security Agreement, Hub Pen 2017 Security Agreement, Hub Pen 2018 Security Agreement, Best Promotions Security Agreement, HandsStands Security Agreement, Beacon Promotions Security Agreement, Forty Four Security Agreement and Debco Bag Security Agreement, the “Trademark Security Agreements”) Webb Business granted to the Grantee, to secure its obligations under the Collateral Agreement, a security interest in all right, title and interest of Webb Business in and to certain intellectual property;

WHEREAS, the Hub Pen 2016 Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) at Reel 5759 Frame 0243 on March 24, 2016;

WHEREAS, the Hub Pen 2017 Security Agreement was recorded at the USPTO at Reel 6207 Frame 0008 on November 16, 2017;

WHEREAS, the Hub Pen 2018 Security Agreement was recorded at the USPTO at Reel 6355 Frame 0180 on June 18, 2018;

WHEREAS, the Best Promotions Security Agreement was recorded at the USPTO at Reel 6207 Frame 0033 on November 16, 2017;

WHEREAS, the Hands Stands Security Agreement was recorded at the USPTO at Reel 6508 Frame 0070 on December 21, 2018;

WHEREAS, the Beacon Promotions Security Agreement was recorded at the USPTO at Reel 6508 Frame 0024 on December 21, 2018;

WHEREAS, the Forty Four Security Agreement was recorded at the USPTO at Reel 6466 Frame 0024 on December 21, 2018;

WHEREAS, the Debco Bag Security Agreement was recorded at the USPTO at Reel 6354 Frame 0833 on June 18, 2018;

WHEREAS, the Web Business Security Agreement was recorded at the USPTO at Reel 7096 Frame 0618 on November 5, 2020; and

WHEREAS, each Grantor has satisfied the terms of the applicable Trademark Security Agreement and requests a specific release of the security interest granted and recorded against its intellectual property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreements, as applicable.

SECTION 2. Termination and Release. The Grantee, without representation, warranty, or recourse, hereby:

(a) terminates each Trademark Security Agreement and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of each Grantor (and any of the borrowers or other obligors under the Collateral Agreement) in and to all intellectual property, whether granted pursuant to the Trademark Security Agreements or otherwise (and including, but not limited to, the Trademarks listed on Schedule A attached hereto);

(b) assigns and transfers to each Grantor all of its right, title and interest in and to all intellectual property, whether granted pursuant to the Trademark Security Agreements or otherwise (including, but not limited to the Trademarks listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby; and

(c) authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at each Grantor's expense.






