PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This Partial Release of Trademark Security Interest ("Partial Release") is effective as of May 9, 2023, by Churchill Agency Services LLC, in its capacity as Agent for all Lenders (the "Agent") to Prosci, Inc. (the "Grantor"), as follows:

WHEREAS, on October 21, 2021, the Grantor and the Agent entered into that certain Trademark Security Agreement ("Security Agreement");

WHEREAS, pursuant to said Security Agreement, the Grantor granted to the Agent, a continuing security interest in all of the Grantor's right, title and interest in its Trademark Collateral (as defined therein), including but not limited to the trademark listed on the attached Schedule A (the "Released Trademark");

WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on October 21, 2021, at Reel/Frame 007468/0156;

WHEREAS, the Agent wishes to release its security interest in the Released Trademark listed on Schedule A only and retransfer and reassign to the Grantor without recourse all of the Agent's right, title and interest in and to the Released Trademark listed on Schedule A.

NOW THEREFORE, the Agent hereby releases any security interest it may have in the Released Trademark listed on Schedule A only, and reassigns any and all right, title and interest it may have in and to the Released Trademark listed on Schedule A without recourse to the Grantor.

This Partial Release is applicable only and solely with respect to the Released Trademark and to no other Trademark Collateral arising under the Security Agreement (the "Retained Collateral"). The Agent retains all security interests, liens, rights, titles and interests granted to the Agent under the Security Agreement with respect to all such Retained Collateral, and the Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Partial Release.
