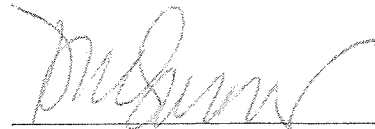
1. They are the president and the secretary, respectively, of DDi Global Corp., a California corporation.
