RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is effective as of February 14, 2023 and granted by KeyBank National Association, as collateral agent (the "Agent") for the lenders under the Credit Agreement referred to below (the "Secured Parties"), in favor of K & N ENGINEERING, INC., a California corporation (the "Grantor").

WHEREAS, pursuant to that certain Second Lien Credit Agreement, dated as of October 20, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among K&N Merger Sub II, Inc., a Delaware corporation ("Merger Sub"), and following the consummation of the Acquisition, K&N Parent, Inc., as borrower (the "Borrower"), K&N Intermediate Holdings II, Inc., as Guarantor (the "Parent"), the other Guarantors party thereto from time to time, the Agent, as Administrative Agent and Collateral Agent, and each lender from time to time party thereto (collectively, the "Lenders" and individually, a "Lender"), and that certain Second Lien Security Agreement, dated as of October 20, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Borrower, the Parent, the Grantor, K&N Acquisition, Inc., and the Collateral Agent, the Grantor granted to the Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and executed and delivered to the Agent that certain Second Lien Trademark Security Agreement, dated as of October 20, 2016, by and between the Grantor and the Agent (the "Trademark Security Agreement") for recording with the United States Patent and Trademark Office (the "USPTO");

WHEREAS, the Trademark Security Agreement was recorded with the USPTO on October 20, 2016, at Reel 5905, Frame 0480; and

WHEREAS, the Credit Agreement has been terminated and the Grantor has requested that the Agent enter into this Release in order to evidence the release and reassignment to the Grantor of any and all right, title and interest the Agent and the Secured Parties may have in the Collateral pursuant to the Trademark Security Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement, Security Agreement, or Trademark Security Agreement, as applicable.

2. Release of Security Interest. The Agent, on behalf of itself and the Secured Parties, without recourse to or representation or warranty by the Agent of any kind, hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Trademark Security Agreement in any and all right,

title, and interest of the Grantor, and reassigns to the Grantor any and all right, title, and interest that it may have, in, to and under the following Collateral:

(a) all registered trademarks and pending applications for trademarks of the Grantor that constitute Collateral, including trademark registrations and applications set forth in Schedule 1 hereto;

(b) all income, fees, royalties, damages and payments then and thereafter due and/or payable to the Grantor with respect to any of the foregoing, including damages, claims, and payments for past, present or future infringements thereof; and

(c) all rights to sue for past, present and future infringements thereof.


3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
