TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of November 30, 2016, is executed by PNC BANK, NATIONAL ASSOCIATION ("Agent"), in favor of METABO CORPORATION ("Grantor").

WHEREAS, Grantor previously granted to Agent, for its benefit and the benefit of Lenders, a security interest (the "Security Interest") upon, and assigned to Agent, for its benefit and the benefit of Lenders, all of the Grantor's right, title and interest in, certain Collateral more particularly described on Exhibits A, B, C and D attached hereto, which Security Interest was recorded with the United States Patent and Trademark Office at Reel 004680, Frame 0771, on December 15, 2011 (as amended from time to time, the "Security Agreement"), for the purpose of securing payment and performance of certain obligations of the Grantor to Agent and Lenders (the "Obligations");

WHEREAS, capitalized terms used but not defined herein have the meanings given to such terms in the Security Agreement;

WHEREAS, on or prior to the date hereof, Grantor has paid and performed in full the Obligations and, as such, Agent, for itself and the Lenders, has agreed to terminate the Security Agreement and to release, and terminate its security interest in, the Collateral and assign and transfer to Grantor all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to re-vest in Grantor the entire right, title and interest to the Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Agent, for itself and the Lenders, hereby releases and terminates the Security Interest and assign and transfers to Grantor, without representation, warranty or recourse, all of Agent's right, title and interest in and to the Collateral, effective as of the date set forth above.
