This **IP SUPPLEMENT**, dated as of May 15, 2023, is delivered pursuant to and supplements the Security Agreement, dated as of October 21, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among the grantors named therein and **BARCLAYS BANK PLC**, as the Collateral Agent and is made by Fresh American, LLC, a Delaware limited liability company and Annie Selke, LLC, a Massachusetts limited liability company (each, a “**Grantor**” and collectively, the “**Grantors**”). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.



All such Intellectual Property shall be deemed to be part of the Intellectual Property Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement.




