**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of May 12, 2023, by **ING CAPITAL LLC**, as administrative agent (in such capacity, together with its successors and assigns, “Administrative Agent”) for the Secured Parties as defined in the Credit Agreement (as defined below) in favor of **PRO PETROLEUM LLC**, a Delaware limited liability company with an address at 4710 4<sup>th</sup> Street, Lubbock, Texas 79416 (“Grantor”).

W I T N E S S E T H:

WHEREAS, reference is made to that certain Credit Agreement, dated as of March 4, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among Saratoga RP East LLC, a Delaware limited liability company (“SRPE”), Saratoga Rack Marketing LLC, a Delaware limited liability company (“SRM”), the Grantor, Tartan Oil LLC, a Delaware limited liability company (“Tartan”), GreenAmerica Biofuels LLC, a Delaware limited liability company (“GreenAmerica”), BunkerHill Oil Marketing LLC, a Delaware limited liability company (“BHOM”), Southern Counties Oil Co., a California Limited Partnership, a California limited partnership (“SC Fuels”), SC Commercial, LLC, a Delaware limited liability company (“SC Commercial”), and Cardlock Fuels System, LLC, a California limited liability company (“Cardlock”) and, together with SRPE, SRM, PPL, Tartan, GreenAmerica, BHOM, SC Fuels and SC Commercial, each a “Borrower” and collectively the “Borrowers”), as borrowers, BunkerHill Holdings Company LLC (“BHHC”), Trajectory Acquisition Company LLC (“TAC”), PFJE SOCAL GP Holdings LLC (“Socal GP”), PFJE SOCAL LP Holdings LLC (“Socal LP”) and, together with BHHC, TAC and Socal GP, each a “Guarantor” and collectively the “Guarantors”), the several banks and other financial institutions or entities from time to time party thereto as lenders (the “Lenders”), the issuing lenders from time to time party thereto (the “Issuing Lenders”).

WHEREAS, Grantor entered into a certain trademark security agreement dated March 4, 2020 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on March 4, 2020 at the United States Patent and Trademark Office at Reel 6882, Frame 0355.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of its right, title and interest in and to the Trademark Collateral, including the Trademarks listed in **Schedule A**.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including all of the goodwill related thereto, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens under the Credit Agreement and the other the Loan Documents.
