## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”), dated as of the date of the last signature below is by and between Amyris, Inc., a Delaware corporation (“Parent”), Amyris Clean Beauty, Inc., a Delaware corporation (“Amyris Clean Beauty”), AB Technologies LLC, a Delaware limited liability company (“AB Technologies”), and Amyris Fuels, LLC, a Delaware limited liability company (“Amyris Fuels”, together with Parent, Amyris Clean Beauty, and AB Technologies, the “IP Grantors”), on the one hand, and Naxyris S.A. a Luxembourg société anonyme (“Lender”), on the other hand. Each capitalized term utilized in this Release that is not defined herein shall have the meaning set forth for such capitalized term in the Loan Agreement (as hereinafter defined), but if such capitalized term is not defined herein or therein, such capitalized term will have the meaning as set forth in Article 1, 8 or 9 of the UCC, as applicable, if defined therein.

WHEREAS, Parent, Subsidiary Guarantors and the Domestic Subsidiaries, that have delivered a Joinder Agreement to Lender, (collectively, “Grantors”) own and use in their business, and will, in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below);

WHEREAS, Lender, on the one hand, and Grantors, on the other hand, have entered into that certain Amended and Restated Loan and Security Agreement, dated as of October 28, 2019 (as amended, restated, modified or supplemented from time to time, the “Loan Agreement”), pursuant to which Lender has extended certain financial accommodations to Grantor;

WHEREAS, pursuant to the terms of the Loan Agreement, IP Grantor(s) have executed and delivered to Lender (i) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Parent and Lender as of August 14, 2019, which was recorded with the United States Patent and Trademark Office at Reel 6721, Frame 0851 on August 15, 2019; (ii) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Amyris Clean Beauty and Lender as of August 14, 2019; (iii) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between AB Technologies and Lender as of August 14, 2019; (iv) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Amyris Fuels and Lender as of August 14, 2019; (v) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Parent and Lender as of February 27, 2020; (vi) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Parent and Lender as of April 23, 2020; (vii) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Amyris Clean Beauty and Lender as of April 23, 2020; (viii) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Parent and Lender as of November 17, 2020; (ix) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Amyris Clean Beauty and Lender as of November 17, 2020; (x) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Parent and Lender as of May 21, 2021; and (xi) that certain GRANT OF TRADEMARK SECURITY INTEREST by and between Amyris Clean Beauty and Lender as of May 21, 2021 (the foregoing (i) to (xi) collectively, the “Trademark Security Agreements”);

WHEREAS, pursuant to the Trademark Security Agreements, IP Grantors granted to Lender a security interest in, and Lender became a secured creditor with respect to, the Trademark Collateral; and

WHEREAS, IP Grantors have requested that Lender enter into this Release in order to effectuate, evidence and record the release and reassignment to IP Grantors of any and all right, title and interest the Lender may have in the Trademark Collateral pursuant to the Trademark Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions of the Loan Agreement, Lender hereby states as follows:

1. **Release of Security Interest.** Lender, without representation, warranty or recourse of any sort, hereby (i) terminates each Trademark Security Agreement and (ii) terminates, releases and discharges any and all security interests that it has pursuant to any of the Trademark Security Agreements in any and all right, title and interest of IP Grantors in, to and under the trademarks, service marks, designs, logos, indicia, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and registrations and applications for registration pertaining thereto, owned by IP Grantors and set forth on Schedule A annexed hereto (collectively, the “Trademarks”) in the United States and any state thereof and in foreign countries, and all goodwill of IP Grantors’ business connected with the use of and symbolized by the Trademarks (collectively, the “Trademark Collateral”). Any right, title or interest of the Lender in such Trademark Collateral shall hereby cease and become void. This Release does not terminate, release or discharge the Lender’s security interest in any intellectual property or any other asset of the IP Grantors other than the Trademark Collateral.

2. **Further Assurances.** Lender agrees, at IP Grantors’ expense, to take all further actions, and provide to IP Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as IP Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. **Governing Law.** This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
