Assignor represents that it is the exclusive owner of United States Trademark Registration No. 4178987 and has full right and authority to make this assignment, and that to the best of Assignor's knowledge, this assignment is free of any encumbrances, liens, judgments, security interests, disputes, licenses, claims or actions, and that there are, and have been, no claims pending or threatened with respect to the Mark. Assignor does not represent that it has any rights in the Mark outside of the United States.

Assignor agrees to perform any further acts and execute and deliver any further documents that may be reasonably necessary to carry out the intents and purposes of this Assignment.


