**WHEREAS :-**


- (1) The Assignor is the proprietor in the US of the Trade Mark as set out in the Schedule referred hereto (hereinafter called "the Trade Mark").

(4) The Assignee has been notified that the Trade Mark is registered with the existing exclusive license.


