**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of May 18, 2023 (the “Release”), is made by **BANK OF NEW ZEALAND**, as agent for the Beneficiaries under that certain Syndicated Facility Agreement (as defined herein) (in such capacity, the “Agent”) in favor of **CHURCH COMMUNITY BUILDER, LLC**, a Delaware limited liability company, (the “Grantor”).

**WHEREAS** pursuant to that certain Syndicated Facility Agreement, dated as of December 12, 2019, by and among the Agent, **PUSHPAY LIMITED**, as borrower (the “Borrower”), Agent, as mandated lead arranger and bookrunner and as lender and the subsidiaries of **PUSHPAY HOLDINGS LIMITED** (as amended and restated by that certain Deed of Amendment and Restatement, dated as of August 20, 2021, and as otherwise amended, restated, amended and restated, supplemented or otherwise modified through the date hereof, the “Syndicated Facility Agreement”), Grantor was required to execute and deliver that certain Trademark Security Agreement, dated as of February 26, 2020, in favor of Agent (as amended, restated, or otherwise modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Syndicated Facility Agreement or Trademark Security Agreement, as applicable), and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 26, 2020 at Reel 006875, Frame 0465;

**WHEREAS** pursuant to the Trademark Security Agreement, the Grantor granted to Agent, for the benefit of the Beneficiaries, a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those trademark registrations listed on Schedule I hereto;

**WHEREAS** the Grantor desires Agent to release, discharge, terminate and cancel its security interest in the Trademark Collateral of the Grantor, including the trademark registrations set forth on Schedule I hereto;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Beneficiaries, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademark Collateral of the Grantor, including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Trademark Collateral.

The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.

This Release may be executed by delivery of an executed counterpart of a signature page hereto by facsimile transmission or other **electronic transmission** (i.e., a “pdf” or “tif” file), which shall be effective as delivery of a manually executed counterpart hereof. For purposes hereof, the words “execution,” “execute,” “executed,” “signed,” “signature” and words of like import shall be deemed to include electronic signatures, the electronic matching of assignment terms and contract

formulations on electronic platforms, or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transaction Act.
