**WHEREAS:**

- A.       Canadian Imperial Bank of Commerce, Canadian Imperial Bank of Commerce, New York Branch and CIBC Inc. (collectively the "**Lenders**") granted certain credit facilities to the Borrowers pursuant to a credit agreement dated as of June 15, 2006 (the "**Credit Agreement**").
- B.       Pursuant to the Credit Agreement, some or all of the Borrower, Guarantors and Other Parties (collectively, the "**Releasees**") granted certain security in favour of Canadian Imperial Bank of Commerce as agent (the "**Agent**") on behalf of the Lenders (collectively, "**the Security**") as security for the liabilities and obligations of the Borrowers under the Credit Agreement (the "**Indebtedness**").

**NOW THEREFORE**, for good and valuable consideration (the receipt and sufficiency of which are acknowledged), the Lenders agree as follows:

- 1.       Repayment. The Agent and the Lenders acknowledge and agree that payment in full of all outstanding Indebtedness has been made by the Borrowers and all Credits (as defined in the Credit Agreement) in favour of the Borrowers and all Commitments of the Lenders under the

Credit Agreement are hereby permanently cancelled and terminated and the Credit Documents are hereby terminated, with the exception of the Letters of Credit (as hereinafter defined).

2. Outstanding Letters of Credit. Certain letters of credit issued by one or more of the Lenders remain outstanding as set out in Schedule "A" hereto (collectively, the "**Letters of Credit**") along with certain foreign exchange contracts ("**FX Contracts**"), and the Borrowers have agreed to provide the following cash collateral to the Lenders (the "**Cash Collateral**"):
  - (a) the amount of Cdn.\$210,000 held in Wheels International Freight Systems Inc.'s account no. 95-00316/ 003222 (the "**Cdn. Account**"); and
  - (b) the amount of U.S.\$210,000 held in Wheels International Freight Systems Inc.'s account no. 02-32815/ 003222(the "**U.S. Account**").

Wheels International Freight Systems Inc. has also executed and delivered separate securities pledge agreements, each dated as of December 20, 2006, granting in favour of the Lenders a security interest in the Cash Collateral held in each of the Cdn. Account and the U.S. Account (collectively, the "**New Pledge Agreements**") to secure the liabilities and obligations of the Borrowers under the Letters of Credit and the FX Contracts.

3. Release and Discharge. Save and except for the New Pledge Agreements, the Agent and the Lenders hereby release and discharge all Security and with the exception of the Personal Property Security Act (Ontario) ("**PPSA**") registration made against Wheels International Freight Systems Inc. ("**Wheels**") having file no. 624686031, all other registrations relating to the Security. The Agent and the Lenders hereby authorize and direct any of the addressees or their respective agents to: (i) complete, file and register full and final discharges in respect of the registrations listed in Schedule "B" hereto; (ii) amend CIBC's PPSA registration against Wheels having file no. 624686031 so that the collateral classifications are amended to "Accounts" and "Other" and the general collateral classification refers to the New Pledge Agreements, (iii) delete the undersigned's name as a mortgagee and/or loss payee on any insurance policy maintained by the Debtor and (iv) delete the undersigned's name from title certificates filed in the United States in respect of trailers owned by any of the Borrowers or Guarantors. The Agent and the Lenders also undertake to do, make and execute, and/or to authorize the doing, making or execution of, all such deeds, documents and things as may be reasonably required to effect and record the release and discharge of the Security and the repayment of obligations secured by the Security at the sole expense of the Borrower.
4. Representations and Warranties. The Agent and the Lenders each represent and warrant that it has not sold, transferred, assigned or encumbered or agreed to sell, transfer, assign or encumber any of the Credit Documents or any of its interest in the collateral described in the Security.
5. The provisions hereof shall enure to the benefit of the Borrowers, Guarantors and Other Parties and their successors and assigns and shall be binding upon the successors and assigns of the Agent and the Lenders.

acknowledged, the Agent and the Lenders undertake to and agree with each of the Releasees that upon the Agent and the Lenders receiving indefeasible payment in full of the Indebtedness, inclusive of interest thereon to the date of payment, the Agent and the Lenders shall deliver to the Releasees a duly executed release substantially in the form attached as Schedule "B" to this undertaking.
