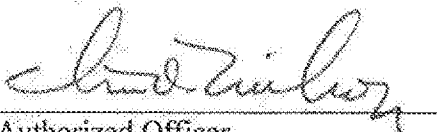
I. The name of the corporation (which is hereinafter referred to as the "Corporation") is: Intrado IP Communications, Inc.
