**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of May 22, 2023 is made by Eclipse Business Capital LLC (f/k/a Encina Business Credit, LLC), as agent for certain lenders (in such capacity, including any successors thereto, the "Grantee").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of September 4, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and between, among others, The McClatchy Company, LLC (f/k/a SIJ, LLC), a Delaware limited liability company (the "Grantor"), the Lenders from time to time party thereto and the Grantee, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Notice of Security Interest in Trademarks, dated as of September 4, 2020 (the "Trademark Security Agreement"), a security interest (collectively, the "Security Interest") was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was submitted for recording with the United States Patent and Trademark Office on September 8, 2020 at Reel/Frame 7046/0526; and

WHEREAS, the Grantee now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral, including those trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Grantee hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement or the Loan Agreement, as applicable.

2. Release of Security Interest. The Grantee, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademark Collateral, and any right, title or interest of the Grantee in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Grantee authorizes the Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Grantor's expense. The Grantee further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or its agents or designees) reasonably request (at the Grantor's sole cost and expense) in order to confirm this Termination and Release and the Grantee's right, title and interest in, to and under the Trademark Collateral.

4. Choice of Law. This Termination and Release shall be governed by, and construed in accordance with, the laws of the state of New York.
