TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this “**Assignment**”) is made and entered into as of May 5, 2023 (the “**Effective Date**”), by and between Bear Republic Brewing Company, Inc., a California corporation (“**Assignor**”), and Artisan Brewers, LLC dba Drakes’ Brewing Co., a California limited liability company (“**Assignee**”). Assignor and Assignee are sometimes collectively referred to herein as the “**Parties**.”

RECITALS

WHEREAS, Assignor is the sole and exclusive owner of, and has used and/or intended to use, the names and trademarks set forth on Exhibit A attached hereto and incorporated herein by this reference, together with any common law trademark rights (collectively, the “**Trademarks**”), and is the sole and exclusive owner of the business goodwill related to the Trademarks and symbolized thereby.

WHEREAS, Assignee desires to acquire from Assignor all of its rights, title, and interest in the Trademarks and all business goodwill related therewith.

NOW, THEREFORE, incorporating the Recitals, and in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignor hereby irrevocably assigns, grants, conveys, and transfers to Assignee, as of the Effective Date, all of Assignor’s rights, title, and interest in and to the Trademarks as part of the entire business or portion thereof to which the Trademarks pertain as required by Section 10 of the Trademark Act (15 U.S.C. § 1060), together with the goodwill of the Assignor’s business connected with the use of and symbolized by the Trademarks, all application and registration rights with respect to the Trademarks, all common law rights, trade name rights, and rights of any kind whatsoever accruing under or relating to the Trademarks provided by applicable laws, free of all liens and monetary encumbrances, and all rights to damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement of the Trademarks or injury to said goodwill, together with the right to sue or recover the same in the name of Assignor.

2. The Recitals set forth above are expressly incorporated herein and made a part hereof. The terms of this Assignment shall bind and inure to the benefit of the Parties hereto and their respective heirs, legal representatives, successors, and assigns.


