TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN COLLATERAL

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN COLLATERAL ("**Termination and Release**") dated as of May 10, 2023, is made by MERCANTILE BANK OF MICHIGAN, ("**Bank**") in favor of MIDWEST INNOVATIVE PRODUCTS, LLC, an Illinois limited liability company ("**Grantor**").

WHEREAS, Grantor executed and delivered a Security Agreement dated as of March 31, 2021 (the "**Security Agreement**"), granting Bank a continuing security interest and lien on certain Collateral, as defined below, which was recorded with the United States Patent and Trademark Office at Reel 056123 and Frame 0030 on April 27, 2021 and Reel 7277 and Frame 0032 on April 30, 2021; and

WHEREAS, Grantor has requested that Bank enter into this Termination and Release in order to effectuate, evidence and record the release of any and all right, title and interest Bank may have in the Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby states as follows:

1. Release of Security Interest. Bank hereby terminates the Security Agreement and terminates, releases and discharges any and all security interests and liens that it has pursuant to the Security Agreement in any and all right, title and interest of the Grantor that it may have, in, to and under the following (collectively, the "**Collateral**"):
 - a. any and all patents, patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership, including the patents and patent applications listed in Schedule 1 hereto, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the "**Patents**"); and
 - b. any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof ("**Trademarks**").
