TRADEMARK ASSIGNMENT AGREEMENT

Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts that Assignee may require in order to vest all of Assignor's right title, and interest in and to the Mark in the Assignee and / or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.

The Assignment may be signed in any number of counterparts, including electronic counterparts, with the same effect as if the signature on each counterpart were on the same instrument.
