**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made effective as of December 22, 2021, by **REGIONS BANK**, a Georgia corporation (in such capacity, the “Lender”) in favor of **IEQ CAPITAL, LLC**, a Delaware limited liability company with an address at 950 Tower Lane, Suite 1800, Foster City, California 94404 (“Obligor”).

W I T N E S S E T H:

WHEREAS, Obligor entered into the Pledge and Security Agreement dated as of June 28, 2021 (as the same may be amended, modified, extended or restated from time to time, the “Security Agreement”) with Lender.

WHEREAS, pursuant to the Security Agreement, Obligor entered into a Notice of Grant of Security Interest in Trademarks (the “Trademark Notice”) with Lender, which was recorded on June 29, 2021 at the United States Patent and Trademark Office at Reel 7339, Frame 0169.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Notice, as applicable.

WHEREAS, Obligor granted to the Lender, under the terms of the Security Agreement, a continuing security interest in, and a right to set off against, any and all right, title and interest of Obligor in and to its trademark registrations and trademark applications, including without limitation those listed in **Schedule A**, and the goodwill associated therewith (collectively, the “Trademark Collateral”).


