**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “Release Agreement”), dated as of May 25, 2023, is made by **BANK OF AMERICA, N.A.**, a national banking association, as Agent (“Grantee”) in favor of **CERTIFIED ORIGINS, INC.**, a Delaware corporation (“Grantor”).

WHEREAS, Grantor and Grantee are parties to that certain Loan and Security Agreement dated as of June 19, 2020, as amended and restated by that certain Amended and Restated Loan and Security Agreement dated March 30, 2022, in which the Grantor delivered to the Grantee that certain Memorandum and Notice of Security Interest in Intellectual Property dated June 19, 2020 (the “Memorandum”) whereby the Grantor granted the Grantee a security interest in certain trademarks of the Grantor, including the trademarks and trademark applications listed on **Schedule A** attached hereto (the “Secured Trademarks”) for recordation with the United States Patent and Trademark Office (the “USPTO”); and

WHEREAS, the Memorandum was recorded with the USPTO on June 19, 2020 at Reel 6974 / Frame 0698; and

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

WHEREAS, the Grantee has agreed to terminate and release its security interest and all of its right, title and interest in each of the Secured Trademarks, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

1. **Release and Assignment**. The Grantee hereby discharges, terminates and releases its security interest in all of the Secured Trademarks, and the Grantee hereby assigns and transfers to the Grantors, without recourse, all of the Grantee’s right, title and interest in and to each of the Secured Trademarks and the related registrations and goodwill, effective as of the date set forth above.

2. **Further Assurances**. The Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantors’ sole cost and expense.
